Early Learning & Child Care Center

A warm, welcoming environment for infants, toddlers, preschoolers, and nursery aged children, with options for before and after school care to support families' diverse schedules.

Dental Care

Comprehensive dental services for children and young adults with special needs, ensuring accessible, compassionate care.

In-School Dental Care

Bringing dental services directly to Region One/ Botelle School and Torrington Public Schools, making it easier for children to receive essential care right where they learn.

Pathway To Success

Guiding high school students in exploring their unique strengths and future goals through aptitude testing and career counseling, paving the way for bright futures.

Relatives As Parents Program

A warm, nonjudgmental support group for grandparents and relatives stepping into the role of primary caregivers, providing resources, guidance, and a sense of community.

Community Partnerships

Community partnerships are an essential part of the child care program at Brooker Memorial. We are grateful to the organizations and individuals that support our work, often behind the scenes, helping us provide high-quality care and enrichment for the children we serve. We also value those who have visited our classrooms or hosted activities, giving our students opportunities to learn, explore, and connect with the community.

Child Care & Early Learning Center

The annual Halloween Parade happened in October 2024 with infants and toddlers visiting Doyle's Medical Supply, PAC Group, and Hartford HealthCare while preschoolers visited Keystone Place, where they trick-ortreated with the senior residents, sang songs, shared snacks, and got creative with some fun crafts

Oliver Wolcott Technical High School visited Dec. 20, 2024, bringing Santa and his elves to meet with child care students, take photos and the students were able to share what they wanted for Christmas.

Socks galore were on display at Brooker Memorial March 21, 2025 in observance of World Down Syndrome Day. Children and employees donned colorful and mismatched socks to show support for people with Down Syndrome.



The Week of the Young Child was observed April 7-11 and it was full of activities, including a sing-a-long and Dance Party, a visit from the ice cream truck, a large mural created by painted feet, a Spring Walk visiting PAC Group and Doyle's Medical Supply, where students searched for colorful Easter eggs.



Brooker Memorial joined the celebration May 9 to plant one of 183 trees that were distributed by Eversource CT in Torrington in partnership with the Arbor Day Foundation. Children in the Child Care Center helped plant the donated Dogwood in the front yard at Brooker.

Brooker's Child Care students cheered loudly June 5 during the 39th Annual Law Enforcement Torch Run for Special Olympics Connecticut, as the runners went by.

We are grateful for the moments our children shared, bringing joy to seniors, welcoming special visitors, honoring important causes, and joining in traditions that make Brooker a vibrant place to grow.

Community Partnerships

Brooker Memorial's dental program provides comprehensive care, creating a true dental home for children where preventive services, treatment, and oral health education go hand in hand. Through partnerships with schools, community organizations, and health providers, we expand access, promote healthy habits, and reduce barriers to care. We are grateful to all our partners who support our work throughout the year, helping children in our community build healthy smiles and brighter futures.

Dental

Oral hygiene education was shared at the WIC (Women Infant Children) office at Torrington Area Health District by dental hygienist, Julia, who visited in November 2024 and May 2025. The goal is to empower our community with essential knowledge about oral hygiene techniques and nutritional counseling to help prevent early childhood tooth decay. The presentations are offered in both English and Spanish to ensure all families benefit. Brooker presents every six months at WIC, alternating between early childhood and adolescent dental health.

A HUSKY Dental Forum discussion was hosted at Brooker Memorial June 18 as an opportunity for Torrington area residents to share their experiences with Medicaid dental services, with a total of 40 people participating. The event was presented by the Connecticut Oral Health Initiative (COHI) in collaboration with the state Department of Social Services.



We have dental providers that specialize in serving students with special needs and were happy to join the Torrington Area Families for Autism's first TAFA Walk Our Way and Resource Fair May 31 at the Action Wildlife Sanctuary in Goshen. Brooker was part of the Resource Fair to share information about childcare and dental care with free toothbrushes and 2-minute brushing timers.







New Dentists join **Brooker**

Two new dentists, Dr. Suher Baker and Dr. Carlos Braverman, join Brooker

Brooker has been pleased to welcome a new Dental Director, Dr. Suher Baker, and a general dentist, Dr. Carlos Braverman, to the Dental Center during the 2024-25 fiscal year.

Dr. Braverman joined the practice in August, having previously worked at B&B Dentistry in Torrington and New Hartford. Dr. Braverman is fluent in Spanish. He has been a welcome addition to the Brooker staff, treating pediatric patients with care, concern and his wonderful sense of humor.

Dr. Baker, BDS, DMD, MS, MBA, joined us in January and has infused her enthusiasm to combat dental fear into the staff. The response from patients has been fantastic! One of her earliest patients declared he's not afraid of the dentist anymore and it is a refrain often heard repeated by her patients. Dr. Baker has a very child-centered approach and established an "I am Brave" board where patients are recognized for their bravery, resiliency and confidence. She is multilingual, speaking several languages including Spanish. Her research focuses on the burden of dental disease and reducing dental-related fear and anxiety.

Dental Outreach extends to schools, camps and day care centers

Brooker's in-school dental hygienist
Deb Ravlin had a busy year traveling to
Il different schools throughout the school
year to provide dental education and
dental hygiene services to children. Brooker
was able to offer this program through
the generosity of the Foundation for
Community Health, Delta Dental Foundation,
and The Torrington Savings Foundation.

The students participating receive dental cleanings, fluoride, oral health screenings and sealants. Sealants are a coating that protects the teeth and helps prevent tooth decay. The schools include elementary schools in Torrington, Region 1 (Cornwall, Falls Village, Kent, North Canaan, Salisbury, and Sharon) and the Botelle School in Norfolk.

All children are eligible for the services. Any family that does not have insurance will not be billed for services provided at the schools. Parents find it very convenient as they don't have to miss work to take their children to a dental office. Children also miss less class time because travel time is eliminated.

In the summer months, Deb travels to summer camps and day care centers throughout Litchfield County to provide dental education to children as young as three years old. She has also developed a game that school-age children play to raise their awareness about the level of sugar contained in foods and beverages.

Ruth Chadwick Care Closet

Brooker has been supporting children and families in the community for over 100 years. Sometimes families find themselves needing a little help from time to time due to various reasons such as loss of employment, death in the family, illness, fire, and other causes. Brooker Memorial is fortunate to have the Ruth Chadwick Care Closet in memory of Ruth Chadwick, a former board member, corporator, and volunteer. Through the care closet, we are able to help families with monetary or material support. The funds from the care closet are used for both onetime needs and for providing Christmas gifts to families in our programs who are identified by Brooker staff.



Community Food Drive

Brooker Memorial participated in the United Way Northwest Connecticut's Days of Caring in June as one of the businesses offering a designated location to collect non-perishable food. Food collected was given to 12 food pantries.

Community Partnerships

Brooker Memorial's Pathway to Success program helps high school students discover their natural abilities through aptitude testing, guiding them toward future career paths. This initiative is made possible through partnerships with the Johnson O'Connor Research Foundation, Torrington High School, and generous local professionals who share their time and expertise.
